Rental Agreement

In exchange for the rental of Rental Equipment for the Rental Term and at the Rental Rate, You agree to the terms and conditions of this Rental Agreement. The Rental Fee will be due in full prior to your picking up of any of the Equipment from All City Sound. You agree to return the Equipment in the same condition as when you picked it up from us and are responsible for any damage, loss, theft or malfunction of the gear while you have possession of it.

Late Fees

In the event that you return the Rental Equipment late (after the Due Date), You agree to pay additional fees as follows: (a) Additional Rental Fees will be charged at the same daily Rental Rate as was charged for the Rental Term (partial days will be charged at the full daily rate); and (b) A late fee of Fifteen (15) Percent (of Additional Rental Fees) will be charged.

Unreturned Equipment

In addition to paying for all Rental Fees and Additional Rental Fees, You agree to pay the Purchase Value for any Equipment that is not returned for more than seven (7) days.

Damaged Gear

In the event that the Equipment is returned to All City Sound in a damaged, incomplete, or inoperable condition, you agree to pay for the Purchase Value.

Security Deposit

In addition to a credit card authorization, You agree that we may charge You a security deposit for the Equipment, to be security against loss or damage of the Equipment or non-payment of any Rental Fees.

Unpaid Sums and Remedies

You agree that we may charge your credit card and/or any security deposit for any unpaid sums that you incur under this Rental Agreement (including those for Rental Fees and for any lost, unreturned, and/or damaged Equipment). In the event that you do not pay for all the sums set forth in this Rental Agreement, we shall have all legal and equitable rights and remedies to collect all fees due to us and/or to recover the Equipment. You also agree to pay for all costs of recovery for repossession and collection of damages for unpaid sums, including attorney's fees.

Authorization

You authorize us to review your credit reports and agree to leave a credit card authorization so that we may charge you for any unpaid sums.

No Liability and Limitation of Liability

All City Sound is not responsible for, and accept no liability for injuries, faulty performance of, or failure of the Equipment to perform as desired. All City Sound is not responsible for training you to use the Equipment properly. You agree to accept the Equipment "as-is" and with no warranties of any kind. You agree that All City Sound is not responsible for any losses or damage, including consequential, incidental, direct and the like, even if we have reason to know of the likelihood of such damages. In any event and under all circumstances, our maximum liability to You under this Rental Agreement is for the Rental Fee. It is your responsibility to check the Equipment for suitable condition and operability prior to accepting the Equipment.
